The Reading Housing Authority Board of Commissioners held a Workshop and Regular Meeting on Tuesday, August 22, 2023, at the William W. Willis Center for Administration, 400 Hancock Boulevard, Reading, PA.

WORKSHOP MEETING

Chairwoman Lorena Keely opened the meeting by expressing how well attended Wacky Water Wednesday was at Oakbrook Homes playground on August 16. Glenside Homes Wacky Water Wednesday will be held on August 23 at 1 pm. The Reading Recreation Commission, the Reading Water Authority and the City's fire, police, and public works departments all play a part in making the events happen.

RHA employees recognized by the board this month included Clarisol Saez who was promoted from a Customer Service Assistant at Center City Campus to a Housing Specialist in Applications. Also recognized by the board was Myra Morales, a newly hired Customer Service Assistant at Center City Campus.

Stacey Keppen, Executive Director, was honored by the board for 25 years of service.

Ms. Keely then turned the meeting over to Stacey Keppen who reviewed the Public Housing Maximum Income Limits and the Housing Opportunity Through Modernization Act of 2016 which establishes guidelines and income limitations for continued occupancy in public housing for over-income households.

Highlights of the Executive Director's report included the following:

1. Utility management strategies were discussed in regard to an intended recapture by HUD from RHA's 2022 Energy Performance Contract. Facility Strategies Group, LLC has been retained to provide an analysis to support operational improvement.
2. A recent presentation to Commonwealth of Pennsylvania House Representatives for additional funds to address the third phase of Oakbrook Homes Center for Community Services Project
3. A grant through Highmark Wholecare to fund digital signage in the highrise common areas.
4. The recent formation of a Resident Council at Franklin Tower.

The next Commissioners Meeting will be held on Tuesday, September 26, 2023, starting at 4 pm.

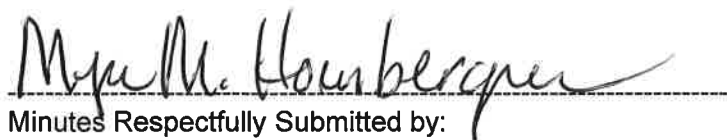
